Summer 1973 Cultural Treasure Trove Uncovered at Regis

A year or two before the turn of the century, one of the Jesuit priests who manned tury, one of the Jesuit priests who manned the science department of Sacred Heart College took a field trip down into the Four-Corners area where Colorado, New Mexico, Arizona, and Utah meet. It was almost certainly Father Armand W. Forstall, metallurgist, chemist, geologist, and mathematician. Fortunately, he didn't stick to any one of his specialties, but tourist-fashion brought home to the college several boxes of Pueblo pottery a total of perhaps sixty pieces. These were kept in the science area of the Pink Palace, which was at the turn of the century practically the whole of the Regis physical plant. In the twenties they were taken over to the new labs in Carroll Hall dorm, and finally in the sixties moved to the new Science Building, where they sat in a display case in the hallway, uncleaned and unlabeled. A good excuse for the last omission was that there was no documentation with them at all excepting a scrap of paper with the unsatisfying words "Near Adamana, partly from Winslow, Ariz... part in N.M. .. Navajo Indians found ... 1898-99 ... prehistoric ... Prof. Jensen in charge of Mesaverde ... Prof. Smiley." Not much to go on.



The eagle is especially sacred to the Hopi Indians of today's Arizona. The design on this creamy yellow bowl, drawn by an ancestor of theirs seven centuries ago, shows in X-ray fashion a lightning-and-arrow "lifeline" running from the bird's heart out through its mouth. This is an age-old primitive artistic technique, as is the profiled head with both eyes visible: PERSPECTIVE TORDUE, twisted perspective, familiar to us in the cubist paintings of Pablo Picasso.

The pottery was, at any rate, the work of the Pueblo people, a group of southwestern Indian tribes who had developed a unique way of life long before Columbus got lost trying to find India. These Indians had wandered through the semi-arid plateaus of the Four-Corner Area for perhaps hundreds of years, hunting and gathering what unaided nature offered them. Then, gradually over the course of centuries they became dominantly agricultural, settled down in "apartment houses" they learned to build, developed great irrigation systems which demanded large amounts of manpower to maintain, and evolved a system of

religious ritual and myth suited to an agricultural people, one directed to insuring the fertility of their crops, especially the coming of rain when it was needed. As they had become sedentary, they had begun to make pottery — which of course a nomadic people would spend all its time breaking and gluing back together.

a nomadic people would spend all its time breaking and gluing back together. The descendants of the Pueblo Indians still live in the Rio Grande River valley from Taos south to Albuquerque and on the mesas and plateaus west from there to the Hopi villages in Arizona.

These were the people who made the pots that Regis had; but the question remained: which items came from which periods and which places?

periods and which places? IN the 1970's, Regis College saw the beginning of a modest minority studies program and the addition of anthropology to the social science area. With this, it became highly desirable to make an in-vestigation of the neglected collection. Some of the pottery was cleaned with weak hydrochloric acid to remove the depsit of calcium that had formed on the surface while the bowls had lain buried in the earth through many centuries, with water earth through many centuries, with water trickling down after ever rainstorm; designs of startling clarity often appeared, most often deftly drawn in black lines on a brilliantly white background. Then the Denver Museum of Natural History was kind enough to lend Bacis the expertise of Mr. Bobert Regis the expertise of Mr. Robert Akerley, their curator of Southwestern art, who examined the collection and was able to tell us that we were the lucky owners of a collection which, almost certainly rather by accident than design, happened to be nicely representative of the main strands of the Pueblo tradition. There was some material from the 700-1100 A.D., and a great deal from many areas of the "Great Pueblo" era of 1100-1300, including some from Mesa Verde in "Developmental Pueblo" period of about southwestern Colorado, a very fine group from Chaco Canon in northwestern New Mexico, a few very fine pieces from the (Continued on Page 8)

Rev. Dr. Robert Jerome Starratt, S.J., who became principal of Regis High School on May 31, upon the resignation of Rev. James Baker who will enter doctoral studies next fall.

studies next fall. Other trustees, all members of the Society of Jesus (Jesuits) are: Rev. Dr. David M. Clarke, president of the Regis Educational Corporation; Rev. James H. Baker, former Regis High School principal; Rev. Dr. William T. Miller, associate professor of chemistry at Regis College; Rev. Dr. Harold L. Stansell, professor of history at the college; and Rev. Arthur O. Verdieck, of the Regis High School faculty.

High School faculty. Father Casey said the Trustees had decided to enlarge the Board in order to strengthen and enrich it by the addition of men with broad experience and outstanding qualifications. "Trustees of the high calibre of our four

added. Father Hennesey, a leading historian of American Catholicism, has been professor of modern church history at Jesuit School of Theology at Berkeley (California) since 1971. Previously he served nine years on the faculty at Fordham University in New York. He also has been a visiting professor at the Gregorian University (Rome), Union Theological Seminary (New York), Memorial University of Newfoundland and Stanford University. He holds an A.B. degree from Loyola University and he completed his theological studies at Woodstock College before being ordained to the priesthood in 1957. His Ph.D. in history was earned in 1963 at Catholic University of America, Washington, D.C.

history was earned in 1963 at Catholic University of America, Washington, D.C. Father Reinert, a native of Boulder, Colorado, has earned a national reputation as an outstanding educator, author, citizen and intellectual. He holds 16 honorary degrees in addition to an earned Ph.D. from the University of Chicago, a licentiate in sacred theology and A.M. and A.B. degrees from Saint Louis University. He is chairman of the Association of American Colleges, president of the National Council of Independent Colleges and Universities and is a member of numerous councils, commissions and boards.

Before becoming president of Loyola Academy, Father Reinke served there as rector, headmaster and director of guidance. An accomplished pianist, he is believed to be the first priest in the United States to appear as a soloist with a major symphony orchestra. He also has produced TV variety programs and performed regularly in the Loyola Community Theatre Forum. His doctoral studies at Loyola were in psychology and his experience includes service in state hospitals and the Cook County Psychopathic Hospital. He earned an M.A. from Loyola in Greek.

Father Starratt has been recognized nationally for his leadership role in developing the Jesuit Secondary Education Association and is considered to be an authority on curriculum theory and on high school program design. He was principal of Fairfield (Connecticut) Preparatory School before coming to Regis High School as associate principal in 1972. He has helped revamp the Regis program by introducing many innovations and providing for more coordination with Regis College. Father Starratt has a doctorate from the University of Illinois

Father Clarke Kicks Off Luncheon Series

Colleges are good for business because they create discriminating customers, president Clarke told a group of Denver alumni and businessmen earlier this year at the first of a series of Downtown Regis Roundtable luncheons held in Denver.

Father Clarke said the primary function of a college or university is to focus on values, principles and goals.

"This pursuit of values, principles and goals actually results in a public with which a businessman can have credibility," he said. "The American businessman does not want a public that can be COMPLETELY swayed by advertising alone. He wants customers who can think, reason, understand what is value and what isn't. He wants customers who can make up their minds and stick with their decisions. Otherwise, the public would be so fluid, so flexible that whoever advertised this week would get all the business."

He said colleges and universities provide needed forums "where people can come together and confront a wide spectrum of ideas and commitments, evluate them, then internalize those that he or she chooses, and finally pass on to others the new insights and understandings that one has gained from the experience."

Private colleges perform these functions in a uniquely effective way, he added. The colleges also provide a forum for religious discussion, he said, noting that many Catholics still are "in a state of shock" because of the changes within the church that have occurred during the past 10 years. He cited three "flavors" of Catholics:

• Those who preferred the old days • Those who like the changes but

• Those who want ever-accelerating

change Father Clarke called for understanding and prayerful confrontation among these three schools of thought. He said Regis includes members of all three schools "and is proud of this fact." He described Regis as cosmopolitan with more than half the student body of 1,200 coming from outside a 300-mile radius and with about 15 percent being Catholic and almost 40 percent being women. "We Catholics don't live in a ghetto any longer, and we don't want Regis to be a ghetto," he said.

The program for the annual meeting included a report from Regis President, David M. Clarke, S.J., and a talk on "Jesuit Education in the 70's" by Robert J. Starratt, S.J., Associate Principal of Regis High School.

Human Dignity Week

Among the speakers at the first Regis College "Human Dignity Week" January 29 to February 2 were: Dr. Hanna Gray, dean of arts and sciences at Northwestern University and the first woman arts and sciences dean in the "Big Ten" colleges; The Rev. Walter J. Ong, S.J., author and scholar in both the Renaissance and contemporary culture and a professor of English at St. Louis University; Prof. Elise Boulding, associate professor of sociology at the University of Colorado and a project director in the CU Institute of Behavioral Sciences; and the Rev. Mr. Walden Toeves, Boulder county commissioner and former CU chaplain.

Another speaker was Mrs. Cynthia Warrick Kemper, an authority on the arts, member of the President's advisory committee on the Arts, John F. Kennedy Center, and co-founder of the Performing Arts Foundation in Kansas City, Mo.

Tuition Hike

President David M. Clarke, S.J., announced in April that the college would raise its tuition by five dollars, to \$55 a credit hour, next fall. Another five dollar increase will become effective in the fall of 1974.

In a message to the Regis students and staff, Father Clarke said Regis was affected by rising costs in the same way that all other areas have been affected.

Father Clarke said Regis tuition was the lowest among private four-year colleges in Colorado and among the lowest at comparable Jesuit colleges.

Summer Theology Workshop

Several nationally known educators, lecturers and entainers were on the Regis College campus in May as part of a summer workshop in theology.

Comedian Mort Sahl; Marshall McLuhan, author and lecturer; George Leonard writer and educator; Khigh Diegh, Taoist spiritual leader, were among out-of-state speakers who presented evening programs at the Regis Field House.

Two Initiated into Alpha Sigma Nu

A prominent Denver businessman and a Regis College professor have been chosen for membership in Alpha Sigma Nu, honorary fraternity for Jesuits.

The two men, John J. Sullivan, president of Bosworth Sullivan and Co., Denver investment firm, and Dr. William Levings, professor of geology at Regis, were initiated February 22 at the Regis College Center. Both graduated from Regis College in 1915.

Alpha Sigma Nu has 6,000 members in the United States. Membership is based on scholarship, loyalty and service. The Regis chapter was founded in 1966. Sullivan is a trustee of the Bonfils Foundation and the Denver Foundation and is

Sullivan is a trustee of the Bonfils Foundation and the Denver Foundation and is active in many civic groups. He is past president of the Rotary Club of Denver, Denver Community Chest, and the Board of Governors of the Association of Stock Exchange Firms. He is past chairman of the Board of Governors of the National Association of Securities Dealers, and past governor of the Investment Bankers Association. In 1942 he was designated Knight at St. Gregory the Great by Pope Pius XII, and in 1961 he was named a Knight of Malta.

Regis College honored him in 1966 by presenting to him the coveted Civis Princeps_ (First Citizen) Award.

Dr. Levings joined the Regis College faculty in 1957 after serving 31 years on the faculty of the Colorado School of Mines from which he received both masters and doctoral degrees in science. His articles on geology have appeared in many publications. In 1972 he received the Regis Outstanding Faculty Award at the Spring Honors Banquet. In 1965 he was presented with the Alumni Achievement Award.

The Colorado moderator for Alpha Sigma Nu is the Rev. Francis J. Moriarty, associate professor of philosophy at Regis.



Composer-conductor Meredith Willson received an honorary degree of doctor of fine arts at the college's annual Honors Convocation, March 16 in the Field House. Willson was honored for his many contributions to the enrichment of American life through both popular and serious music.

Known to many as "Mr. Music Man" because of his authorship of one of the nation's most popular musicals, Meredith Willson is a musician, conductor, composer, writer and actor. Coloradans know him especially for the "Unsinkable Molly Brown" but he also has been acclaimed for hits such as "Here's Love," "You and I," "I See the Moon," and "It's beginning to Look Like Christmas."

The convocation also featured the annual Faculty Lecture, delivered by the Rev. Edward L. Maginnis, S.J. theology professor and chairman of the Theology Department. Father Maginnis has taught at Regis since 1958 and has also participated in the development of a fine arts program and in many community activities, primarily in the arts. Among the recent changes at Regis cited by Father Clarke were:


Increased emphasis on personal responsibility rather than imposed, monastic-style discipline.

More demanding academic programs.

Increasing numbers of women and of laymen on the staff, which is now only 25 percent Jesuit compared to 100 percent a decade ago.

The Regis goal, however, continues to be "to better equip a person to enter the industrial, professional or educational fields by providing an atmosphere in which the student can be educated, broadened and humanized while probing the fundamental questions of his or her life," he said.


The second semester of the 1972-73 academic year produced many unexpected events in the Regis Athletic Department and the Basketball program seemed to hold the spotlight.

seemed to hold the spotlight. The Baskerball team, lead by Tony DuCros and Dave Meller, finished the 1972-73 season with 14 wins and 11 loses. But this was only to last a short time. The Rangers were forced to forfeit eight games due to the ineligibility of Frank Jefferson. This startling event was overshadowed by the announcement of Wayne Monson, Basketball Coach, that he planned to retire to enter private business. James Karabetsos has since been named to replace Monson as head coach. A former teammate of Monson's at Northern Michigan University, Karabetsos has served as Head Basketball Coach at Denver University, 1971-72, and assistant coach at Kansas University this past year. After viewing video tapes of last year's team and a vigorous recruiting program, Karabetsos is optomistic about next years' Basketball program.

With the advent of Spring, Baseball, Tennis, Golf, and Track, blossomed into competition. Progress was hindred by the lack of practice time outside due to the weather condition. Although the Baseball team was able to defeat such noted powers as Colorado State University and Wyoming University, the Rangers were only able to put together a 7-14 record. The problem seemed to lie in the lack of depth, especially in the pitching staff. Snow and wet grounds again played havoc with the schedule early in the season forcing the cancellation of six games. Sam Radovich lead almost every hitting department on the Regis stats, and gained national recognition as one of the top 50 hitters in the final NAIA Baseball report. First year coach, Bill Meyn is also very optimistic about next year's Baseball program.

The two newest Spring Sports, Golf and Tennis, have grown in popularity very fast the last few years. Although neither team faired as well as hoped this year, each should return even stronger next year. Golf Coach Lou Kellogg will have five experienced players leading his team into competition. Included will be leading medalists Dennis McLaughlin and Jim Watson. Although no one has been named to replace Wayne Monson as Tennis Coach, it is apparent that Regis will be a leading contender with Vic Aguilar and Bill Kent returning to the courts.

One Intercollegiate sport will be dropped from the 1973-74 Regis Athletic program. Track will not return next year due to the lack of interest and financial support. It is a grave dissappointment for the men who competed on this years' team. Their individual efforts were outstanding but the team could not measure up to the level of the larger schools.



Hopi area in northern Arizona, and a little from the Gila River area further south in the same state. Furthermore, there was an interesting if spotty collection of pottery from the very end of the nineteenth centuary — including a good deal of what is jestingly referred to among anthropologists as "Early American Tourist." But the collection does include some of the first attempts at the "archaistic" style which has since become the dominant trend in Pueblo pottery: imitations of the shapes, colors, and design-patterns which the earliest anthropologists in the southwest excavated — often while employing descendants of the original dwellers as laborers and cooks. The Pueblo women of the end of the last century, frequently on the suggestion of anthropoligists, imitated the older artifacts as best they could and thereby started the vigorous contemporary pottery tradition.

All this material, supplemented by a few borrowed pieces and some purchased for the purpose, now form a large display in the main lobby of the Science Building, where after seventy-five years of anonymity each of them has once again been labeled by period and place of origin and thus constitutes a cultural treasuretrove and a valuable teaching device for

This years' accomplishments on the athletic fields can be classified as average for a Regis program. But next year can be the beginning of something that has not been seen on campus for a long time, and that is an athletic program that compliments the academic program.

Father Clarke told the audience, that Regis was proud of the record its graduates had made.

"Regis is not a training ground designed to equip graduates to step into a specific job as a store manager or personnel director. If it were, it would represent a collosal waste of time and talent. Our job is to equip our students to learn, to adapt to new situations, to cope with the inefficiency of other human beings, to understand logic and people. We think we are doing this better than ever before."

In discussing the "tyrannies of American life," Father Clarke noted the encroachment of the public sector into the minority studies and anthropology alike.

EDS NOTE: Fr. Steele has taught English at Regis since 1968 and has spent his summers from 1969 to the present researching the Spanish heritage of the Southwest operating out of Albuquerque. He plans to complete a book based upon his research this summer. Father Steele collected Spanish antifacts for several years before coming to Regis.

private sector, to the danger of private education, especially in the areas of tax law revisions and the autonomy of some federal agencies.

"We feel that the nation has a strong need for independent schools as a real alternative and counter-balance of the growing number of schools that are controlled by governmental agencies," he said.

"We must find viable solutions for the survival of independent schools, which cannot be independent with the support of the American People."

Subsequent Roundtable luncheons were addressed by John Flood, assistant professor of Business Administration, and Dale Tooley, Denver District Attorney.
